### **Expressions of interest**

The Government of the Republic of Kenya (GoK) has applied for financing from the French Development Agency (AFD) toward the cost of the 220kV Ring Around Nairobi Metropolitan Area and intend to apply part of the agreed amount for this credit to payments under the contract for Provision of consulting services for Supervision and Management of the Project completion.

The services under this project will include, but not limited to, the following:-

- Supervising the construction works, any integration works and certifying payments to contractors;
- Preparation and submission of detailed project implementation schedules to KETRACO and to the financiers;
- Reviewing Construction, Operation and Maintenance Agreements as well as Operation and Maintenance Manual;
- Reviewing and approving of technical documents including contractor's detailed design during execution of the contracts;
- Administration of all contracts:
- Preparation of monthly, quarterly and annual progress reports;
- Preparation of Project Completion Report;
- Follow-up of any issues during the defect liability period.

The duration of the assignment is expected to be two (2) years during which the Consulting firm is expected to provide the services for a period of 15 calendar months.

KETRACO invites eligible consultants to indicate their interest in providing these services. Interested consultants must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions and availability of appropriate skills among staff, company profile and financial status).

For the purpose of demonstrating <u>experience</u> in the expression of interest, consultants should list at <u>least three (3)</u> and <u>at most ten (10)</u> successful project implementation experiences in each of the four (4) items indicated below:

- General Experience of Consultant in Power System Projects not less than fifteen (15) years,
- Specific Experience of Consultant in Design and Supervision of Transmission Lines and Substations of 220 kV HVAC and above not less than ten (10) years
- Technical and Managerial Organization of the Firm
- Experience of the Consultant in sub-Saharan Africa

Consultants may constitute joint-ventures to enhance their chances of qualification.

The Client will prepare a short list of at least three candidates to be pre-selected on the basis of the expressions of interest received to whom he will send a Request for Proposals to perform the services.
